SLSA is the peak coastal water drowning prevention authority performing numerous rescues, preventative actions, and first aid treatments each year.

- (d) provide Nippers with an educational and practical experience in a wide range of subjects and skills within the beach environment.
- (e) prepare Nippers for their eventual transition into active patrol involvement in the Club.
- (f) manage funds derived from the fees and subscriptions of members, donations, grants, payments, subsidies and other such sources as may be approved by the Club.
- (g) use and apply funds in promotion of the objectives of the Club.

This Report documents the activities of Sawtell Surf Life Saving Club Inc for the 2020-21 Season and includes the Audited Financial Statements and Balance Sheet for the year ended 30th April 2021.

### Patrols

Patrols were diligent on Sawtell Beach and congratulations to all patrolling members for maintaining a safe beach with no major incidents. 61 members assisted on covering Christmas Day which was a credit to all concerned.

### Competition

Well done to all those competitors who represented Sawtell. With both the Country Titles and Inter-Branch being cancelled competitor numbers were down on past seasons.

Thank you to all competitors for your dedication to training. Thank you to the coaches who spend countless hours with their competitors.

To be able to compete the Club must be able to provide a minimum number of officials apart from water safety and IRB crews. Sadly the Club is lacking in officials so that should be a priority next season.

# **6-PRESIDENT'S REPORT**

In addition many of our club members pitched in on the day to assist with set up, packdown and a huge contingent of water safety. I think everyone involved can be justifiably proud of the success and positivity of that event and it is something we can hopefully replicate in the future.

The Club Redevelopment program has continued to see the improvement and enhancement of our Club precinct. The Auditorium upgrade has significantly transformed that space, and greatly enhanced its potential to earn revenue for the club as a 'venue for hire'. The expansion of the cafe area with the additional paving area has resulted in new commercial arrangements with the Kiosk and again opportunities for increasing club revenue. The completion of the driveway, including the planting has improved the first impression so important to the community. # **7-TREASURER'S REPORT**

Despite COVID-19, my second year as Treasurer was less hectic than my first. As the pandemic control measures were rolled out, generous financial assistance was received from Surf Life Saving governing bodies. This enabled Sawtell Surf Life Saving Club to provide a significant discount on annual memberships and carnival entry fees to our active members and nippers. The Club also received financial support from Council and government bodies. This assisted with the extra cleaning and sanitation supplies needed to minimise potential transmission of the virus within the Club. Thanks to Peter Hirth for taking on the role of Covid Safety Officer to enable the Club to comply with the restrictions.

The Club's recent major building works were completed and paid for this financial year, with now only one major project, the proposed Waste Compound Facility, the only incomplete job at this time. Garry Murray has been a fantastic source of expertise and assistance in both seeing these projects to completion and in the planning future developments.

Completion of the many building works prompted a revaluation of the Club premises, which revealed the clubhouse facilities now has considerably higher value. This resulted in the need to adjust the Club's insurance cover, triggering substantially increased insurance premiums. The Club has also made multiple insurance claims in recent years which has further raised our insurance premiums. Thanks to Steve Kelly in drawing on his wealth of experience to provide guidance to the Club on all matters' insurance. These increased insurance expenses have been incurred at the start of the new financial year, so will appear in next year's annual accounts.

Other major projects/ purchases this year included the acquisition of a new ute for beach patrols, improvement of the outdoor dining area on the eastern side of the Clubhouse and completion of auditorium and members' room upgrades. Members continue to enjoy the new improved Club facilities, with the gym and members' room enjoying greater use. The new look auditorium is also enjoying many and varied activities. It is fabulous to see the community benefiting from the improved facilities and the club benefiting from the increased income.

It was great to see the Coffs Ocean Swims proceed this year after pandemic restrictions stopped it last year and adverse weather nearly prevented the event occurring this year. Substantial rain in the lead up to the event did unfortunately prevent some of our entrants from attending. Over the two years the event proved to be a reasonable income earner for the Club. There was a lot of work done by many people and an enormous amount of work done by Kerry Bayliss, without whom the event would not have been possible. The fabulous work done by Brooke Hanson, Michael McFarlane and Yvonne Briggs also helped to make the event a great success. We look forward to hosting the event next year – hopefully without anything preventing the event from proceeding! We hope the lessons learned from our first hosting of the event will assist in make next year's event even more successful. Thanks to major event sponsor Beachside Radiology as well as Coffs Harbour City Council, Kennards Hire, Mike Blewitt Ford, Quality Hotel City Centre, Stocks and Hogan. Thanks also to the organisations which helped during the event including Rotary Club of Coffs Harbour Daybreak, Coffs Harbour Volleyball Association, Marine Rescue Coffs Harbour, Sawtell Swimming Club and the Surf Life Saving Clubs of Coffs Harbour, Urunga and Red Rock.

Thank you to all members of the committee who, due to their valuable time and effort, help the Club to function. All members should consider doing at least a year on the committee ... as they say, "many hands make light work".

There is a tremendous level of sponsorship provided by the business community to the Club and the surf lifesaving mission. to support the Club. The money we spend in our community comes back to us both as it stays in our community and reinforces our unity and community spirit.

I continue to be amazed and impressed by the benevolence and generosity of many people and businesses who have provided donations to the Club over the period. Your donations are much appreciated and provide the Committee with the opportunity to purchase much needed equipment to support our mission.

Work is currently underway on planning of a new waste compound facility to better manage the Club's waste with the assistance of the NSW Sport grant funding. The club currently holds monies in the sum of \$42,473.20 including GST which must be used in the construction this new waste compound facility.

Having encountered sizeable auditing and accounting costs last financial year, the Club has used the auditing services of Peter Irish this year. Peter provides auditing services to other clubs in the branch and his provision of service to our Club is appreciated. Thanks to John Wake for assisting the Club to locate an auditor with expertise and experience in SLS auditing at a more manageable cost.

As shown in the attached annual reports, total income for the year was just over \$300,000, while total expenditure was just under \$234,000, leaving net surplus for the Club's financial year ended 30 April 2021 the sum of \$68,095.64 (compared to \$382,973.11 last year). The primary cause of the discrepancy in the annual surplus across the two years is the grants received by the Club during the periods.

The Club continues to be in a sound financial position and capable of meeting all foreseeable future commitments. We remain optimistic that the Club can obtain significant grant funding to progress its planned Clubhouse expansion soon.

# **8-CLUB CAPTAINS REPORT**

By every measure Sawtell has had a very successful year ensuring the safety of locals and visitors alike to our beach.

This season a total of 174 patrolling members undertook 4812 hours of patrol over the season which commenced at the beginning of the September school holidays last year and finished on the 25 April. We were fortunate in that there were no COVID concerns this patrolling season, however the weather did play havoc towards the end with large dangerous seas resulted in a number of patrols being surveillance only.

78 members achieved 100% patrol awards. 100% awards are made to those members who undertake all their own rostered patrols or who arrange a swap with a member of another patrol so that the patrol strength remains unaltered.

These members are the backbone of the Club and their efforts are greatly appreciated. Each of these 78 members undertook a minimum of 35 patrol hours which is the minimum requirement. Notably 22 of those members patrolled for more than 50 hours each during the season.

In addition the club recognised 20 members for their patrolling efforts by way of Certificates of Appreciation. Most of these were awarded to members who commenced patrolling during the season and subsequently undertook all of their patrol duties. We also recognised those who helped for part of the season as work or holidays allowed.

This season we performed 17 rescues which was more than the 4 performed last season and 6 in the season before that. Rescues are of course the result of something going wrong. Most of our work is designed to prevent the need for rescues in the first place by ensuring that the flags are in the right place and that preventative actions occur when needed to keep people between the flags. We undertook 173 preventative actions this season which was significantly more than the number performed last season. We also closed the beach to swimmers when things were just too unsafe.

The Patrols provided First Aid on 11 occasions. The majority of these were relatively minor marine stings, cuts and abrasions.

While the number of visitors to the beach can only be a rough approximation the record shows that 55,508 people visited the beach during patrolling hours of which 10,888 swam between the flags. The number of visitors was significantly more than those recorded last season.

The result of these efforts or if you like the proof that this is worthwhile is demonstrated by the fact that there were no drownings or near drownings at Sawtell this season. We did not need to use the resuscitation skills which we train for and renew at the annual skills maintenance sessions.

As Bellinger Valley / North Beach was unable to provide IRB Drivers and Crews some of their patrols this year we provided assistance on several occasions. In addition this year the Club provided water safety for an event held at Mylestom, and were heavily involved in the water safety at for the Ocean Swims.

This patrol season, our trainers put through 41 members to gain their bronze medallion with 11 of those being our SRC kids upgrading their qualification to the Bronze Medallion.

I have enjoyed my first year as Club Captain, and would like to thank those who have made my transition an easy one and have supported and mentored me during this time, particularly, Club Vice Captain, Steve Rayson,

To the patrol captains and members of their patrols, the dedicated members who ensure that our equipment, vehicles and IRBs are always ready to go, the club committees and many others who contributed to ensuring the 2020/21 patrol season was a success – I thank you.

Together we ensured that we continued to provide very high quality surf life saving services at Sawtell.

# **11- CHIEF TRAINING OFFICERS REPORT**

It has been an extremely busy year for training at Sawtell SLSC with COVID still prevalent and this impacted with training modified.

Between 1 May 2019 and the 30 April 2020, our members including juniors (Nippers) have achieved 257 SLSA Education awards and certificates - an outstanding effort. Congratulations to all who achieved these awards.



The names of the recipients of the major awards are included at the end of this report. It shows the willingness of members to continue updating and gaining new skills which will be of benefit to themselves, their family and the community that we, as a surf club, serve.

For some, the season continued through the off season. In August nine (9) members and instructors braved the cold air and successfully obtained their IRB Crew certificate.

In September, six (6) members stepped up and completed their Silver Medallion Beach Management award, one (1) member completed the Silver Medallion Advanced First Aid (AID), five (5) members obtained their Gold Medallion (Advanced Lifesaving) award, one (1) member obtained the First Aid (AID) award, and one (1) member obtained their IRB Crew award.

In the October school holidays, five of our younger members with several Manly juniors completed a shortened bronze Medallion course. We also saw seven (7) members complete their Silver Medallion IRB Drivers award, one (1) member obtained their First Aid (AID) award and two (2) members ventured to Coffs Harbour where they were able to obtain their Bronze Medallion via a shortened course.

This season, our Club ran several Bronze Medallion courses and Surf Rescue Certificate (CPR endorsed) courses. In all we trained 41 new Bronze Medallion holders (which also included students from The Armidale School) with 11 'Nippers' taking their first step into the senior surf club by achieving their Surf Rescue Certificate (CPR Endorsed). This season we trialled running seven (7) parents through their Surf Rescue Certificate

This is a great result and congratulations to these members for their outstanding effort. It is important for us as a club to continue to develop, support and encourage these younger members as they do represent the future of our club and surf lifesaving. The large number of new bronze medallion holders this season will add to our patrol strengths in the coming year. It is hoped that those community members we have trained which includes participants from The Armidale School will become involved in surf lifesaving clubs when their situation allows.



These new members along with our current members will continue to ensure that the level of safety that the public is accustomed to is continued and maintained on Sawtell Beach.

Further during the season, the club ran several other courses with six (6) members obtaining their Advance Resuscitation Techniques award and fourteen (14) U11 Nipper members obtained their Resuscitation (AID) award.

I would particularly like to thank my fellow trainers for their hard work and contribution throughout the season. Surf lifesaving is continuing to increase the workloads put on our training officers with paperwork and the like due to our VETAB accreditation, so the effort put in by our training officer's is phenomenal. I know that our course participants are particularly appreciative of the effort put in by these people throughout the year.

Thanks, must also go to the branch and their assessors for their work throughout the year in assessing our members.

As can be seen from the listing of SLSA Awards there were a range of courses conducted by the club and branch which our members were involved in. Hopefully we will be able to organise more of these courses in the lead up to and during the next season and I would encourage everyone to consider participating.

I am very appreciative and pleased with the effort put in by the club's training officers and I look forward to seeing their participation in the upcoming season.

Once again congratulations to everyone. Keep up the great work and I encourage you to continue your involvement with surf lifesaving and the Sawtell SLSC to keep the community and visitors of Sawtell and surrounding areas safe on the beach.

# **12- JUNIOR ACTIVITIES SUB COMMITTEE REPORT**

All younger age groups have also achieved awards involving Surf awareness and beach safety, basic rescue and first aid techniques, as well as beach environmental protection. Sportsmanship, healthy participation and encouragement of other club members continue to be encouraged in our activities. We also congratulate the parents who have achieved their SRC/Bronze Medallion.

# Competition

This season had 156 registered Nippers, which was more than 10% more than the previous few years.

As mentioned before the Competition in Surf life-saving has been affected by COVID-19. Credit goes to all those involved in the North Coast Branch who managed to coordinate and run three carnivals during this season, in the new and successful 'block racing format. Our Club had great participation at these three carnivals in the **North Coast Branch** (twice in Woolgoolga and in Minnie Water).

Congratulations to all Nippers who competed against the best in the State, with many excellent individual and team results.
