WE ARE SAWTELL SURF LIFE SAVING CLUB



Our Club: a place to belong, grow and be safe

Sawtell SLSC is a charitable, community based, not-for-profit volunteer organisation.

Sawtell SLSC is one of the 8 clubs within the North Coast Branch of Surf Life Saving NSW, the 129 clubs within Surf Life Saving New South Wales (SLSNSW) and the 313 clubs within Surf Life Saving Australia (SLSA).

SLSA is the peak coastal water drowning prevention authority performing numerous rescues, preventative actions, and first aid treatments each year.

The goals of Sawtell SLSC include

- (a) prevent or minimise injury and/or loss of life from drowning by the study and practice of methods of lifesaving and first aid
- (b) provide efficient patrols for the protection and guidance of the public who use the area allocated to the Club's control by the local governing authorities
- (c) conduct, encourage and promote surf activities in its many aspects and assist the local governing authorities in providing and improving facilities for same
- (d) provide Nippers with an educational and practical experience in a wide range of subjects and skills within the beach environment
- (e) prepare Nippers for their eventual transition into active patrol involvement in the Club
- (f) manage funds derived from the fees and subscriptions of members, donations, grants, payments, subsidies and other such sources as may be approved by the Club
- (g) use and apply funds in promotion of the objectives of the Club

3. SECRETARY'S REPORT

On behalf of the Executive and General Committee I am pleased to present the 90th Annual Report for your consideration and adoption.

This Report documents the activities of Sawtell Surf Life Saving Club Inc for the 2021-22 Season and includes the Audited Financial Statements and Balance Sheet for the year ended 30th April 2022.

This report is a snapshot of the year's activities. Please read the more in-depth reports and other information contained herein.

Patrols

Patrols were diligent on Sawtell Beach and congratulations to all patrolling members for your valued contribution. That 50 members assisted on Christmas Day which was a credit to all concerned.

Finance

The Club remains in a strong financial position with cash on hand and investments being \$285138

Grant monies received in 2020-2021 had not been spent and should not have been shown as income in that year but rather deferred until 2021 – 2022. However the Club accounts show a loss for this financial year, due to income being 37% lower (\$112,327) than for the financial year ended 30 April 2021. Meanwhile expenses were only 9% (\$21,192) less than the previous year. The main decreases in income were grants, membership fees and ocean swims revenue. While the main increases in expenses were due to rising insurance costs and depreciation recorded. In the coming year the Club will incur further costs for completion of the waste compound, while the major component of the grant funding has already been received. For more detailed information please read the Treasurer's Report.

Fund Raising

The major fund-raising event for the Club being the running of the Beachside Radiology Coffs Coast Ocean Swims was cancelled due to water quality concerns and lack of beach following the bout of wet weather that hit the North Coast in March. The Club has set a date for next year's event being Sunday 26th March 2023.

Community Service

Sawtell again took part in the Gotcha4Life 24 Hour Row for mental fitness raising just over \$1000 In conjunction with our Nipper Program the Club trialled an Inclusive Program with great success. The Club, when asked, always assisted in helping out other organisations such as with Anzac Day and the Collectors Fair

Clubhouse and Surrounds

Increased usage of the Clubhouse Auditorium continues with community classes suitable for all ages ranging from gentle fitness to pre-school ballet to ukulele, choir and drumming
Thank you to the Kiosk for their part in ensuring there are always people around the Club during the day. The long-awaited waste management compound has now started with work hopefully completed soon.

Communication

Regular communication within a Club is essential. To those members who are involved in the publication of our bi-monthly newsletter (Gen Dellar) and Social Media (Fiona Lane) the Secretary is extremely grateful.

VALE DAVID JONES

Sawtell SLSC farewelled during the year life member David Jones. David contributed to the community and the Surf Life Saving movement so generously over many years.

David joined Sawtell SLSC in January 1964 and patrolled for over 30 years, holding many positions at Club level including President, Club Captain and Chief Instructor as well as Deputy Superintendent at Branch level

He was a competitor and was a North Coast Branch Champion as a member of surf teams, R&R and March Past David was awarded NSW Surf Life Saver of the Year in 1978 – the first time it had been awarded to a member outside the Sydney area and made a Life Member of Sawtell SLSC in July 1981.

In 1991 David was awarded Sawtellian of the Year and then Coffs Harbour Citizen of the Year in acknowledgement of his contribution to the Surf Club and the Sawtell community. David's contribution to the community and Surf Life Saving was simply outstanding. A true life-saver in every sense of the words.

A new ATV known as the **Jonesy** generously donated by Sawtell RSL, the Club of which David was president at the time of his passing, will ensure his memory lives on.

5. PRESIDENT'S REPORT

Ginagay – before we begin I would like to acknowledge the traditional owners of this land, the Gumbangyirr Nation, and their Elders past and present. I acknowledge and respect their continuing culture and the contribution they make to the life of this region. I extend that respect to all indigenous people who are present.

I am proud and delighted to be celebrating the end of a great season for our club and my final year as President. This season has not been without its challenges not only due to the ongoing impact of Covid-19 but also the weather patterns caused by La Nina which wreaked havoc with our beaches, causing significant flooding, coastal erosion, property damage and heartache.

I would like to think that we are embarking on the season ahead with a sense of renewal and optimism. As myself and other key people move on from their Committee roles, this is an opportunity for new blood to come in, bringing new faces, new ideas and new ways of doing things. I am committed to ensuring a smooth transition for my successor and ensuring they are mentored and coached to the level required and very much set up to succeed.

Our core goal is to protect, promote and save lives. Tragically this past season there have been several lives lost at our, and other beaches in our region this past season. Many of you were involved in these incidents either as an on duty patrolling member or just in the course of being on the spot at the time. I have nothing but the utmost admiration for the way in which these incidents were managed and I know that the intervention of our members was greatly appreciated by the families of those involved. Shelley Lantry in her capacity as Club Captain has continued in this role with great competence and confidence, to the extent that we are seeing much less of Steve Rayson around the club these days. Shelley has overseen a successful season where we have not only met our patrolling obligations but also continue to develop innovative and proactive measures to ensure our patrolling regimes are best practice. Thanks for your great contribution Shelley and for being such a fantastic role model for other women in our club who are keen to take on operational roles.

Our committee is a group of dedicated individuals who are committed to being leaders in their respective roles. Again, I would like to make special mention of Club Secretary, Bruce Macphail who continues to make our club work so well on every front with his characteristic understated style and attention to detail. Bruce will be stepping down as Secretary at our AGM to take a well-deserved break but I know he will remain available to new incoming Committee members and will continue to share his extensive knowledge.

Thanks to Treasurer, Anthea Martin who as always has been thorough and rigorous in her approach to managing the club finances and keeping us on the straight and narrow. Our Vice President, David O'Leary has been a reliable and welcome presence at our meetings.

Amanda Ensbey has continued in the role of Registrar this year and her presence along with her responsive, pragmatic approach has been much appreciated. Keith McPherson and Fiona Lane have also made important contributions in the various roles they play including as committee members, and I have so appreciated having their voice at the table at our meetings.

Education continues to be a key focus and core activity under the leadership of our Chief Training Officer Andrew 'Marto' Martin. Our highly skilled and committed team of trainers invest their time to teach and train our members, often requiring 6.30 starts on freezing winter mornings. The reward for these trainers comes from seeing their newly minted SRC, Bronze Medallion, IRB crewpersons or drivers stepping up to take on roles for their patrols during the season and putting their newly learnt skills into action.

The future of the club are our Juniors. Tiffany Easman has done a great job of leading the Juniors committee who continue to deliver an outstanding Nippers program, teaching our kids valuable surf

skills, knowledge and an awareness of a safe beach environment. It is great to watch these kids grow in confidence and work towards building the skills that will allow them to become our surf lifesavers of the future. I am proud that our Club has demonstrated a strong commitment to safeguarding children and young people, by implementing practices on a weekly basis during nippers and training sessions and communicating the expectation to Nippers and parents/carers at weekly muster and in Club communications. We were also excited to pilot an Inclusive Nippers program last season and look forward to continuing this and welcoming a wider circle of children from our community to our program.

Despite weather and Covid obstacles, Sawtell has had some success this year on the competition front – bringing home medals at both Aussies and State, and placing well as a Country club at both State and Country champs. I'd like to thank and acknowledge our coaches Sean Golding, Greg Russell, Jo O'Leary and Shane Golden who have demonstrated impressive commitment to their roles – they turn up to train in all conditions and support our cohort of competitors in working towards their goals.

Communicating with our membership and the broader community is an ongoing challenge. We are very lucky to have Genevieve Dellar continuing in this important. Gen does an outstanding job applying her graphic expertise to our monthly Newsletter – a slick publication which helps to tell the stories of our club on a regular basis.

I'd also like to thank Garry Murray who, along with Bruce has worked hard towards coordinating the final large project of our Stage 1 Redevelopment plan (our Waste Management compound) which will be completed soon.

Our biggest challenge as a club is ensuring we can share and transfer the skills and knowledge we need to maintain a successful and high functioning organisation. For that we need new people to step up and take on roles, bringing new ideas and improved practices.

From a community and business perspective, the club continues to have a strong working relationship with Duncan and Leesa, licensees of the Kiosk. It's been a great business venture for them and in turn has provided the club and community with an important hub, meeting place and tourist attraction that many flock to at all times of year.

What's on the horizon?

- Continuing the theme of renewal – a new President and Secretary and some new Committee members – watch this space!!
- Completion of our last major works project for the year – the Waste Management compound.
- Hopefully a re-establishment continuation of community engagement initiatives such as the TAS bronze program, the refugee group surf awareness programs and welcoming and educating groups from the bush. Projects such as these have suffered enormously throughout COVID but we are committed to resurrecting them and continuing that contact with other community groups going forward.

6. TREASURER'S REPORT

It's been a relatively quiet year on the finance front when compared to my previous years as Treasurer, with less juggling of bills for Clubhouse renovations and less income and expenses associated with Covid-19. Unfortunately, however the Club's finances have again been impacted by events outside of the Club's control, with some Covid-19 management issues lingering over the past year and weather cancelling the 2022 Coffs Coast Ocean Swims.

Unfortunately, the Club accounts show a loss this financial year, due to income being 37% lower (\$112,327) than for the financial year ended 30 April 2021 with expenses 9% (\$21,192) lower.

The main causes of reduced income were due to less grant funding received, lower membership fees and loss of the anticipated 2022 ocean swims revenue. Rises in income came from a 50% increase in revenue from auditorium/training room hire achieved due to a small increase in hire rates and no Covid-19 lockdowns. The Club's revenue from donations increased by nearly 40% over the period, due mostly to two very generous donations received in memory of past Club members David Jones and Dianne Clark. Both members gave so much to the Club over the many years of their memberships. The generous donations provided to the Club in honour of David and Di are testament their contribution. The Sawtell RSL provided funding for the Club to purchase a new ATV/SSV which has been aptly named in Jonesy's honour, while Di's family have provided a legacy to recognise female participation in the Club for many years to come.

The main increases in expense were due to rising insurance costs and increased depreciation recorded – this being a result of the acquisition of many significant depreciable assets in the past several years. Meanwhile the main causes for reduced expenses were due to less admin fees (mostly auditing and accounting), less waste removal costs, as the Kiosk took control of its waste removal costs, and less building maintenance costs, a reflection of the Club's recent refurbishments.

The most significant upcoming expense is the contract for the new Waste Compound Facility which is currently under construction. This project has been impacted by wet weather and supply shortages, which delayed commencement and continues hinder progress, resulting in increased costs. Once completed this facility will enable the club and kiosk better manage hard and trade waste, bringing our trade waste system into compliance, thus reducing usage fees.

The Club is currently in a reasonable financial position, and it appears to be capable of meeting all foreseeable future expenditure. However, it appears likely that the Club will incur another loss in this coming financial year as the Club will incur further costs for completion of the waste compound, while two-thirds of the grant funding has already been received and only approximately one-third of this funding has been expended to date. Unfortunately, this grant funding, when full acquitted, will only cover approximately 50% of the total costs of the project.

Forecast tough economic times ahead may continue to impact our membership income, as well as our complementary functions of kiosk rental and room hire. However increasing interest rates should provide the Club with some opportunity to increase income from its term deposits. The Club continues to take advantage of various grant opportunities, but the Club's biggest non-SLS goal remains to obtain significant grant funding to complete the proposed full refurbishment of the whole Sawtell Surf Life Saving Clubhouse. As the Clubhouse and surrounds are utilised by so many locals and visitors, a fully refurbished Clubhouse will be a tremendous asset to the Club and the community. Hopefully next year the Club will host the 2023 Coffs Coast Ocean Swims without any cancellation or other events impacting upon attendance. After three years of the event being plagued by weather and the pandemic, we are hopeful that next year's event will be successful and incident-free.

Thank you to the many members of the Sawtell Surf Life Saving Club who continue to provide so much to the Club and assistance to me in support of the Treasurer's role. Whether it be securing grants, hiring the auditorium, obtaining sponsorships, receiving donations or passing on invoices for payment, these tasks all assist me in completing my job.

Special thanks go to:

- The many fabulous individuals and businesses who provide generous donations and sponsorship to the Club. I am impressed by the benevolence and generosity of so many. Your donations and sponsorships are much appreciated and provide the Club with funding to acquire greatly needed equipment and supplies to support the Surf Life Saving mission.
- Bruce Coomber for your great work in collecting and banking many cash receipts from various club activities.

- Kerry Bayliss for your many hours of planning and coordinating the Coffs Coast Ocean Swims only to be left with the difficult task of cancelling the event due to poor water conditions in the final week before the event.

- Leanne Stuart for your great work in obtaining agreements with so many generous businesses who support Sawtell SLSC.
- Thank you also to the other members of the committee who, due to their valuable time and effort, help the Club to function. All members should consider doing at least a year on the committee ... to get an idea of what we do and to inject new ideas and perspectives into the Committee.
- Last, but by no means least, thank you to Bruce Macphail who has provided so much to so many over the past 15 years while you have been Secretary to the Club. Bruce presently does an enormous quantity and quality of work for the Club. During my time as Treasurer Bruce has been my 'right hand man' in counter 'signing' most Club payments, invoicing and quality control. Words cannot adequately express my appreciation to you Bruce and I wish you and Lesley all the very best wishes for the future and that you will continue to be part of the Club.

With the ongoing generous support of our many wonderful volunteers, sponsors and donors we should be capable of weathering whatever the year ahead throws at us.

7. CLUB CAPTAINS REPORT

By every measure Sawtell has had a very successful year ensuring the safety of locals and visitors alike to our beach, despite a number of high intensity rescues.

This season a total of 130 patrolling members undertook 4115 hours of patrol over the season which commenced at the beginning of the September school holidays last year and finished on the 25 April. We were fortunate in that there were no COVID concerns this patrolling season. However the weather did play havoc with large dangerous seas resulting in a number of patrols being surveillance only, tsunami warnings & some locals / visitors to the area failing to heed warnings to remain out of the water.

67 members achieved 100% patrol awards. 100% awards are made to those members who undertake all their own rostered patrols or who arrange a swap with a member of another patrol so that the patrol strength remains unaltered.

These members are the backbone of the Club and their efforts are greatly appreciated. Each of these 67 members undertook a minimum of 35 patrol hours which is the minimum requirement. Notably 15 of those members patrolled for more than 50 hours each during the season, with Life Member Neil Robertson taking the prize for the most patrol hours this season with a whopping 110 patrolling hours! Unbelievable!!

We also wish to recognise and thank the other 63 members who patrolled or commenced patrolling during the season and subsequently undertook patrol duties. We also recognise those who helped for part of the season as work or holidays allowed. As a volunteer organisation we certainly appreciate what time people are able to give to the Club to patrol. Thank you.

This season we performed 8 rescues which was less than the 17 performed last season and 4 in the season before that. Rescues are of course the result of something going wrong. Most of our work is designed to prevent the need for rescues in the first place by ensuring that the flags are in the right place and that preventative actions occur when needed to keep people between the flags. We undertook 254 preventative actions this season which was significantly more than the number performed last season. We also closed the beach to swimmers when things were just too unsafe.

While the number of visitors to the beach can only be a rough approximation the record shows that 43,137 people visited the beach during patrolling hours. The number of visitors was significantly less than those recorded last season – the unseasonable weather definitely played a part in that.

The result of these efforts or if you like the proof that this is worthwhile is demonstrated by the fact that whilst unfortunately there was a drowning and near drowning at Sawtell this season, our members utilised their skills, training and appropriately managed the incidents in a calm and professional manner. This was noted and commented on by emergency services who attended the scene, and is a testament to you all of your dedication to Surf Life Saving. It has been a tough season which was mirrored by similar incidents across the branch.

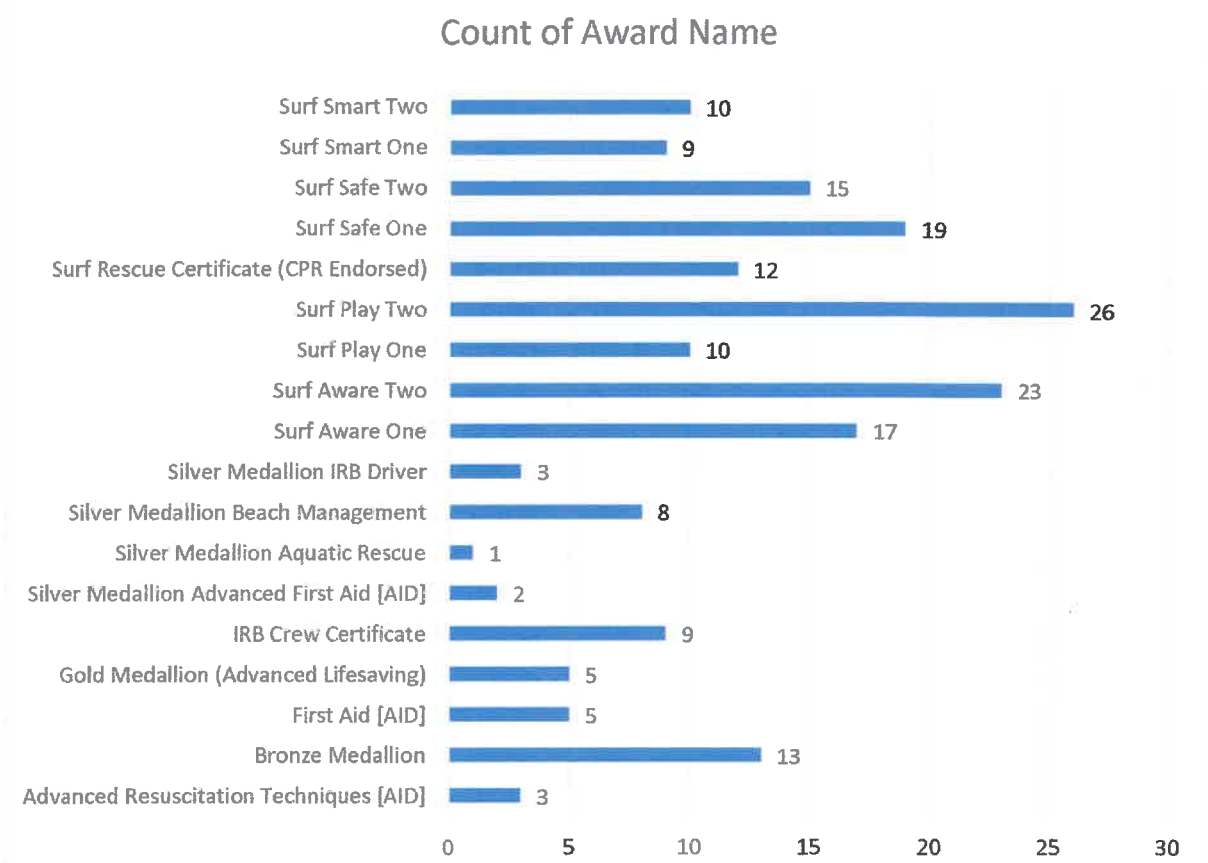

10. CHIEF TRAINING OFFICERS REPORT

It has been an extremely busy year for training at Sawtell SLSC with COVID still impacting on training activities

Between 1 May 2021 and the 30 April 2022, our members including juniors (Nippers) have achieved 190 SLSA Education awards and certificates - an outstanding effort. Congratulations to all who achieved these awards. It shows the willingness of members to continue updating and gaining new skills which will be of benefit to themselves, their family and the community that we as a surf club serve.



For some, the season continued through the off season. In May, three (3) members obtained their bronze medallion, one (1) member obtained Silver Medallion Beach Management and two (2) members obtained their Silver Medallion Advance First Aid [AID]. 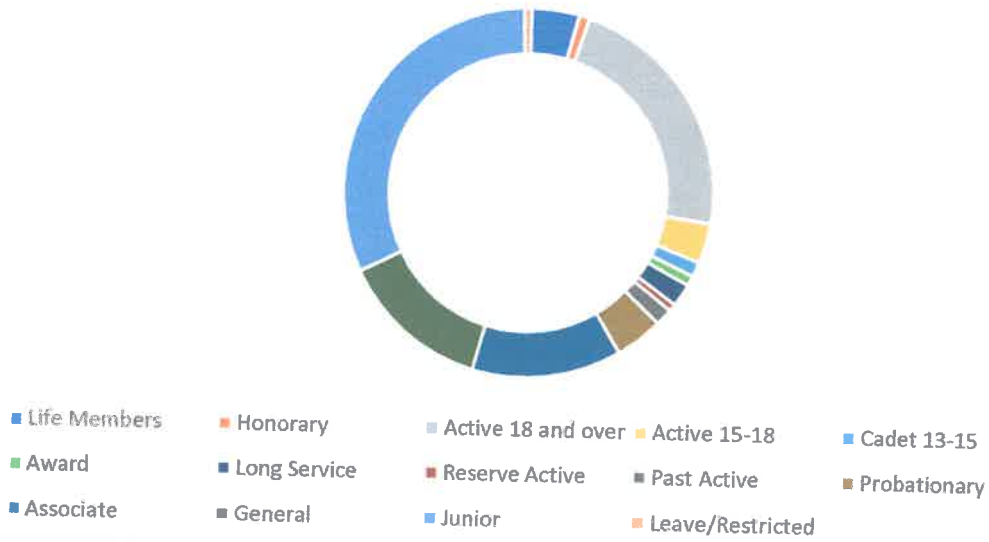

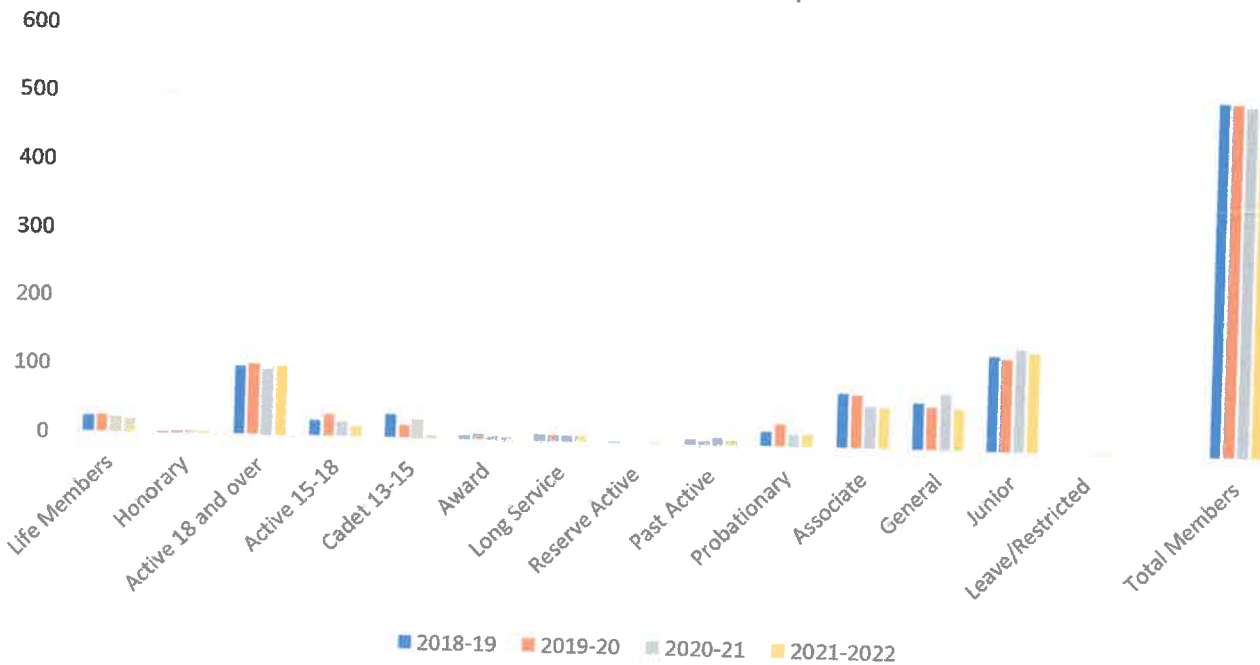
Membership of Sawtell SLS Club has slightly reduced this season likely due to the impacts of Covid.

Significant Changes





NOTES TO THE FINANCIAL STATEMENTS
FOR THE YEAR ENDED 30 APRIL 2022

Note 1: Statement of Significant Accounting Policies

The financial report is a special purpose financial report that has been prepared in order to satisfy the financial reporting requirements of Sawtell Surf Life Saving Club Incorporated. The Committee has determined that the incorporated entity is not a reporting entity.

The financial report covers Sawtell Surf Life Saving Club Incorporated as an individual entity. Sawtell Surf Life Saving Club Incorporated is an entity incorporated in New South Wales under the Associations Incorporation Act NSW 2009.

The financial report has been prepared in accordance with the Associations Incorporation Act NSW 2009, the Australian Charities and Not-for-profits Commission Act 2012 and the following Australian Accounting Standards:

AASB 101:	Presentation of Financial Statements
AASB 107:	Statement of Cash Flows
AASB 108:	Accounting Policies, Changes in Accounting Estimates and Errors
AASB 1048:	Interpretation and Application of Standards

No other applicable Accounting Standards, Australian Accounting Interpretations or other authoritative pronouncements of the Australian Accounting Standards Board have been applied.

The financial report has been prepared on an accruals basis and is based on historical costs and does not take into account changing money values or, except where specifically stated, current valuations of non-current assets.

The following material accounting policies, which are consistent with the previous period unless otherwise stated, have been adopted in the preparation of this financial report.

(a) Income Tax

The committee consider that the association is exempt from income tax under Division 50-5 of the Income Tax Assessment Act of 1997.

(b) Cash and Cash Equivalents

Cash and cash equivalents include cash on hand, deposits held at call with banks, other short-term highly liquid investments with original maturities of three months or less, and bank overdrafts. Bank overdrafts are shown within short-term borrowings in current liabilities on the statement of financial position,

(c) Property, Plant and Equipment

Plant and equipment is stated at historical cost less accumulated depreciation and impairment. Historical cost includes expenditure that is directly attributable to the acquisition of the items.

Depreciation is calculated on a straight-line basis to write off the net cost of each item of property, plant and equipment (excluding land) over their expected useful lives as follows.

Leasehold improvements.	2.5%
Plant & Equipment, Furniture & Fittings	15 - 40%

The residual values, useful lives and depreciation methods are reviewed, and adjusted if appropriate, at each reporting date.

An item of property, plant and equipment is derecognised upon disposal or when there is no future economic benefit to the Association. Gains and losses between the carrying amount and the disposal proceeds are taken to profit or loss.

(d) Investments and Other Financial Assets

Investments and other financial assets, other than investments in associates, are initially measured at fair value. Transaction costs are included as part of the initial measurement, except for financial assets at fair value through profit or loss. Such assets are subsequently measured at either amortised cost or fair value depending on their classification. Classification is determined based on both the business model within which such assets are held and the contractual cash flow characteristics of the financial asset unless an accounting mismatch is being avoided.

Financial assets are derecognised when the rights to receive cash flows have expired or have been transferred and the Association has transferred substantially all the risks and rewards of ownership. When there is no reasonable expectation of recovering part or all of a financial asset, its carrying value is written off.

NOTES TO THE FINANCIAL STATEMENTS
FOR THE YEAR ENDED 30 APRIL 2022

Financial assets at fair value through profit or loss
Financial assets not measured at amortised cost or at fair value through other comprehensive income are classified as financial assets at fair value through profit or loss. Typically, such financial assets will be either (i) held for trading, where they are acquired for the purpose of selling in the short term with an intention of making a profit, or a derivative; or (ii) designated as such upon initial recognition where permitted. Fair value movements are recognised in profit or loss.

Financial assets at fair value through other comprehensive income
Financial assets at fair value through other comprehensive income include equity investments which the Association intends to hold for the foreseeable future and has irrevocably elected to classify them as such upon initial recognition.

Impairment of financial assets

The Association recognises a loss allowance for expected credit losses on financial assets which are either measured at amortised cost or fair value through other comprehensive income. The measurement of the loss allowance depends upon the Association's assessment at the end of each reporting period as to whether the financial instruments credit risk has increased significantly since initial recognition, based on reasonable and supportable information that is available, without undue cost or effort to obtain.

where there has not been a significant increase in exposure to credit risk since initial recognition, a 12 month expected credit loss allowance is estimated. This represents a portion of the asset's lifetime expected credit losses that is attributable to, a default event that is possible within the next 12 months. where a financial asset has become credit impaired or where it is determined that credit risk has increased significantly, the loss allowance is based on the asset's lifetime expected credit losses. The amount of expected credit loss recognised is measured on the basis of the probability weighted present value of anticipated cash shortfalls over the life of the instrument discounted at the original effective interest rate.

For financial assets mandatorily measured at fair value through other comprehensive income, the loss allowance is recognised in other comprehensive income with a corresponding expense through profit or loss. In all other cases, the loss allowance reduces the asset's carrying value with a corresponding expense through profit or loss.

(e) Impairment of Non Financial Assets

At the end of each reporting period, the Association assesses whether there is any indication that an asset may be impaired. The assessment will include considering external sources of information and internal sources of information. If such an indication exists, an impairment test is carried out on the asset by comparing the recoverable amount of the asset, being the higher of the asset's fair value less costs to sell and value in use to the asset's carrying value. Any excess of the assets carrying value of its recoverable amount is expensed to the statement of profit or loss and other comprehensive income.

where it is not possible to estimate the recoverable amount of an individual asset, the Association estimates the receivable amount of the cash-generating unit to which the asset belongs.

(f) Revenue

The Association recognises revenue as follows:

Revenue from contracts with customers

Revenue is recognised at an amount that reflects the consideration to which the Association is expected to be entitled in exchange for transferring goods or services to a customer. For each contract with a customer, the Association: identifies the contract with a customer, identifies the performance obligations in the contract; determines the transaction price which takes into account estimates of variable consideration and the time value of money; allocates the transaction price to the separate performance obligations on the basis of the relative stand-alone selling price of each distinct good or service to be delivered; and recognises revenue when or as each performance obligation is satisfied in a manner that depicts the transfer to the customer of the goods or services promised.

Variable consideration within the transaction price, if any, reflects concessions provided to the customer such as discounts, rebates and refunds, any potential bonuses receivable from the customer and any other contingent events. Such estimates are determined using either the expected value or most likely amount method. The measurement of variable consideration is subject to a constraining principle whereby revenue will only be recognised to the extent that it is highly probable that a significant reversal in the amount of cumulative revenue recognised will not occur. The measurement constraint continues until the Uncertainty associated with the variable Consideration is subsequently resolved. Amounts received that are subject to the constraining principle are recognised as a refund liability.

Sale of Goods

Revenue from the sale of goods is recognised at the point in time when the customer obtains control of the goods, which is generally at the time of delivery.

Donations

Donations are recognised at the time the pledge is made.

Grants

Grants - AASB1058: Income of Not-for-Profit Entities
The Association receives a number of funding streams that do not contain sufficiently specific performance obligations. Where there are no sufficiently specific performance obligations present, the Association recognises revenue on receipt of funds in accordance with AASB1058: Income of Not-for-Profit Entities.

Grants - Specific Capital Grants
Capital grant funding that is received for the acquisition or construction of a specific non financial asset is initially recognised as a liability. The Association recognises income in profit or loss as the entity satisfies its obligations to construct or acquire the specified non-financial asset in accordance with AASB1058: Income of Not-for-Profit Entities.

Interest

Interest revenue is recognised as interest accrues using the effective interest method. This is a method of calculating the amortised cost of a financial asset and allocating the interest income over the relevant period using the effective interest rate, which is the rate that exactly discounts estimated future cash receipts through the expected life of the financial asset to the net carrying amount of the financial asset.

Rent

Rent revenue from kiosk licence and permanent hall hire is recognised on a straight-line basis over the lease term. Lease incentives granted are recognised as part of the rental revenue. Contingent rentals are recognised as income in the period when earned.

Other Revenue

Other revenue is recognised when it is received or when the right to receive payment is established.

Volunteer services

The Association has elected not to recognise volunteer services as either revenue or other form of contribution received. As such, any related consumption or capitalisation of such resources received is also not recognised.

All revenue is stated net of the amount of goods and services tax (GST).

(g) Lessor Accounting

As a lessor, the Association classifies its leases as either operating or finance leases. A lease is classified as a finance lease if it transfers substantially all the risks and rewards incidental to ownership of the underlying asset and classified as an operating lease if it does not.

(h) Goods and Services Tax

Revenues, expenses and assets are recognised net of the amount of GST, except where the amount of GST incurred is not recoverable from the Australian Taxation Office. In these circumstances the GST is recognised as part of the cost of acquisition of the asset or as part of the item of the expense. Receivables and payables in the statement of financial position are shown inclusive of GST.

(i) Trade and Other Receivables

Trade and other receivables represent the funds owing at the end of the reporting period for goods and services provided by the association during the reporting period, which remain unpaid. The balance is recognised as a current asset with the amounts normally paid within 30 days of recognition of the debt.

(j) Trade and Other Payables

These amounts represent liabilities for goods and services provided to the Association prior to the end of the financial year and which are unpaid. Due to their short-term nature they are measured at amortised cost and are not discounted. The amounts are unsecured and are usually paid within 30 days of recognition.

(k) Critical Accounting Judgements, Estimates and Assumptions

The preparation of the financial statements requires management to make judgements, estimates and assumptions that affect the reported amounts in the financial statements. Management continually evaluates its judgements and estimates in relation to assets, liabilities, contingent liabilities, revenue and expenses. Management bases its judgements, estimates and assumptions on historical experience and on other various factors, including expectations of future events, management believes to be reasonable under the circumstances. The resulting accounting judgements and estimates will seldom equal the related actual results. The judgements, estimates and assumptions that have a significant risk of causing a material adjustment to the carrying amounts of assets and liabilities (refer to the respective notes) within the next financial year are discussed below.

Revenue from Contracts with Customers

When recognising revenue in relation to the sale of goods to customers, the key performance obligation of the Association is considered to be the point of delivery of the goods to the customer, as this is deemed to be the time that the customer obtains control of the promised goods and therefore the benefits of unimpeded access.

Estimation of useful lives of assets

The Association determines the estimated useful lives and related depreciation and amortisation charges for its property, plant and equipment and finite life intangible assets. The useful lives could change significantly as a result of technical innovations or some other event. The depreciation and amortisation charge will increase where the useful lives are less than previously estimated lives, or technically obsolete or non-strategic assets that have been abandoned or sold will be written off or written down.

Impairment of non-financial assets other than goodwill and other indefinite life intangible assets

The Association assesses impairment of non-financial assets other than goodwill and other indefinite life intangible assets at each reporting date by evaluating conditions specific to the Association and to the particular asset that may lead to impairment. If an impairment trigger exists, the recoverable amount of the asset is determined. This involves fair value less costs of disposal or value-in-use calculations, which incorporate a number of key estimates and assumptions.

(I) Comparative Figures

When required by Accounting Standards, comparative figures have been adjusted to conform to changes in presentation for the current financial year.

(m) Changes in accounting policy, disclosures, standards and interpretations

New or amended Accounting Standards and Interpretations Adopted

The Association has adopted all of the new or amended Accounting Standards and Interpretations issued by the Australian Accounting Standards Board ('AASB') that are mandatory for the current reporting period. Any new or amended Accounting Standards or Interpretations that are not yet mandatory have not been early adopted.

The adoption of these Accounting Standards and Interpretations did not have any significant impact on the financial performance or position of the Association.

The following Accounting Standards and Interpretations are most relevant to the Association:

AASB 15 Revenue from Contracts with Customers

The Association has adopted AASB 15 from 1 May 2019. The standard provides a single comprehensive model for revenue recognition. The core principle of the standard is that an entity shall recognise revenue to depict the transfer of promised goods or services to customers at an amount that reflects the consideration to which the entity expects to be entitled in exchange for those goods or services. The standard introduced a new contract-based revenue recognition model with a measurement approach that is based on an allocation of the transaction price. This is described further in the accounting policies below. Credit risk is presented separately as an expense rather than adjusted against revenue. Contracts with customers are presented in an entity's statement of financial position as a contract liability, a contract asset, or a receivable, depending on the relationship between the entity's performance and the customer's payment. Customer acquisition costs and costs to fulfil a contract can, subject to certain criteria, be capitalised as an asset and amortised over the contract period.

AASB 16 Leases

The Association has adopted AASB 16 from 1 May 2019. The standard replaces AASB 117 Leases and for lessees eliminates the classifications of operating leases and finance leases. Except for short-term leases and leases of low value assets, right-of-use assets and corresponding lease liabilities are recognised in the statement of financial position. Straight-line operating lease expense recognition is replaced with a depreciation charge for the right-of-use assets (included in operating costs) and an interest expense on the recognised lease liabilities (included in finance costs). In the earlier periods of the lease, the expenses associated with the lease under AASB 16 will be higher when compared to lease expenses under AASB 117. However, EBITDA (Earnings Before Interest, Tax, Depreciation and Amortisation) results improve as the operating expense is now replaced by interest expense and depreciation in profit or loss. For classification within the statement of cash flows, the interest portion is disclosed in operating activities and the principal portion of the lease payments are separately disclosed in financing activities. For lessor accounting, the standard does not substantially change how a lessor accounts for leases.

When adopting AASB 16 from 1 May 2019, the Association has applied the following practical expedients:

- on transition, the weighted average incremental borrowing rate applied to lease liabilities was 5.08%;
- accounting for leases with a remaining lease term of 12 months as at 1 May 2019 as short-term leases;
- excluding any initial direct costs from the measurement of right-of-use assets;
- using hindsight in determining the lease term when the contract contains options to extend or terminate the lease; and
- not apply AASB 16 to contracts that were not previously identified as containing a lease.

AASB 1058 Income of Not-for-profit Entities

The Association has adopted AASB 1058 from 1 May 2019. The standard replaces AASB 1004 'Contributions' in respect to income recognition requirements for not-for-profit entities. The timing of income recognition under AASB 1058 is dependent upon whether the transaction gives rise to a liability or other performance obligation at the time of receipt. Income under the standard is recognised where; an asset is received in a transaction, such as by way of grant, bequest or donation; there has either been no consideration transferred, or the consideration paid is significantly less than the asset's fair value; and where the intention is to principally enable the entity to further its objectives. For transfers of financial assets to the entity which enable it to acquire or construct a recognisable non financial asset, the entity must recognise a liability amounting to the excess of the fair value of the transfer received over any related amounts recognised. Related amounts recognised may relate to contributions by owners, AASB 15 revenue or contract liability recognised, lease liabilities in accordance with AASB 16, financial instruments in accordance with AASB 9, or provisions in accordance with AASB 137. The liability is brought to account as income over the period in which the entity satisfies its performance obligation. If the transaction does not enable the entity to acquire or construct a recognisable non financial asset to be controlled by the entity, then any excess of the initial carrying amount of the recognised asset over the related amounts is recognised as income immediately. Where the fair value of volunteer services received can be measured, a private sector not-for-profit entity can elect to recognise the value of those services as an asset where asset recognition criteria are met or otherwise recognise the value as an expense.

Impact of Adoption

AASB 15, AASB 16 and AASB 1058 have all been adopted using the modified retrospective approach

and as such the comparatives have not been restated. The impact of adoption on opening retained profits as at 1 May 2019 was as follows:

The association has a lease from the Coffs Coast State Park Trust for the land from which the surf club operates. With the exception of short-term leases and leases of low value underlying assets, each lease is reflected on the balance sheet as a right-of-use asset and a lease liability. Variable lease payments which do not depend on an index or a rate (such as lease payments based on a percentage of association sales) are excluded from the initial measurement of the lease liability and asset. The association classifies its right-of-use assets in a consistent manner to its property, plant and equipment

The association has elected to measure right-of-use assets on initial recognition at cost rather than at fair value. The lease of the land from which the association operates is at significantly below market terms and conditions principally to enable the association to further its objectives. The land is leased from the Coffs Coast State Park Trust for \$518 per annum and has a term of 10 years expiring on 31 March 2026.
